FEE SCHEDULE



Pursuant to 14-8-15 NMSA 1978, a County Clerk shall collect a recording fee of \$25.00 for each document filed or recorded by the County Clerk. If a document being filed or recorded contains more than ten entries to be indexed, the County Clerk shall charge an additional \$25.00 for each additional block of ten or fewer entries to the index from each document.

Grantor & Grantee = Each name indexed counts as one entry for indexing. For example:

- Ben White and Ellen White, husband and wife = 2
- Ellen White, Individually and Attorney in Fact for Ben White = 2
- Ellen White Attorney in Fact for Ben White = 2
- Ellen White, aka Ellen Louise White = 2
- Ellen White, aka Ellen Ferguson = 2
- Ellen Ferguson-White = 1
- Ellen White, Personal Representative of the Estate of Charles White = 2

Legal Descriptions = Subdivided Lots = ALL LOTS WITHIN THE SAME BLOCK ARE 1 ENTRY

- Lots 1,2,3 Block 7 School Addition = 1 entry (all contained in 1 block)
- All of Block 7 School Addition = 1 entry
- Lot 1 Block 7 and Lot 1 Block 8 School Addition = 2 entries (2 blocks)

Lots and Tracts that are not inclusive of a Block are indexed as 1 entry

- Lots 7, 12, 15, 78 of Horse Mountain Subdivision = 1 entry
- Tracts A, B and C in Pleasanton = 1 entry

Legal Descriptions = Non-Subdivided = ALL PARCELS WITHIN THE SAME SECTION ARE 1 ENTRY

- SE $\frac{1}{4}$ of Section 7, Township 7 South, Range 12 West = 1 entry (all in 1 Section)
- S $\frac{1}{4}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 6 T7S, R12W = 1 entry (all in 1 Section)
- SE $\frac{1}{4}$ Section 6, SW $\frac{1}{4}$ Section 7 T7S, R12W = 2 entries (2 Sections)
- SE $\frac{1}{4}$ Section 6, SW $\frac{1}{4}$, NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 7, All Section 8 T7S, R12W = 3 entries (3 Sections)

The same above described method shall apply to all document types that are recorded including Survey, Plats and UCC Filings per 55-9-525 NMSA 1978.

 - Without Voting History \$3.00 per 1000 records
 - With Voting History \$4.00 per 1000 records
