

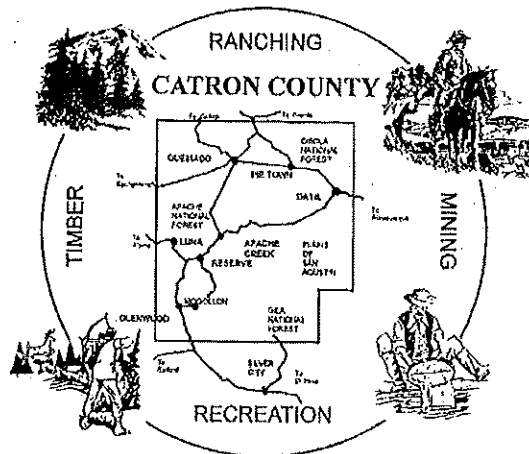

2021 PAID HOLIDAY SCHEDULE

WHEREAS, the Catron County Board of Commissioners met upon notice of meeting duly published at the Catron County Fire Administration Building, 3 Mountaineer Rd., Reserve, New Mexico 87830 on January 14, 2021 at 9:00 a.m. as required by law; and,

WHEREAS, Section 10. 1 (A) of the Catron County Personnel Policy, Ordinance 08-2014 provides that “[t]he County Commission shall approve holidays at their discretion during the first meeting in January of each year, for the calendar year;” and,

WHEREAS, Section 10. 1 (B) of the Personnel Policy states that “[a] paid holiday means up to eight (8) hours paid compensation for time off in recognition of each designated County Holiday. Under no circumstances shall holiday pay exceed 8 hours;” and,

WHEREAS, occasional respite from daily routine is conducive to enhance efficiency and productivity; and,

WHEREAS, the governments of the United States and the State of New Mexico observe days of historical and traditional significance; and,

WHEREAS, advance notification of holidays is necessary for planning by residents of the County and County employees,

NOW, THEREFORE BE IT RESOLVED, THAT:


All departments of the government of Catron County, will observe all holidays as follows:






